# 17.1 (DTCS) Sale of Council Owned Industrial Land - Proposed Lot 1 and Lot 2 (New Industrial Land Subdivision)

## **Executive Summary**

Council has been working with the owners of a Scrap Metal & Trucking business located in Pioneer Street, Parkes, for some considerable time to encourage the business to relocate.

The business has operated in the Pioneers Street location for many years however, the business operation is considered incompatible with the residential zoning and operates only on existing use/rights basis. Residents in the area have raised a number of concerns.

The business has now made an expression of interest to purchase land in the Parkes Industrial Estate to move the business.

Council would be aware that the original intent of the industrial estate was to incentivise businesses operating with the urban areas to relocate to a more suitable bespoke industrial precinct. The industrial estate has been successful in that regard.

The proposed land purchase agreement herein is likely to be one of the few remaining incentivised sales, designed to encourage the relocation of a business away from an urban area

# **Executive Summary**

Parkes Shire Council has sought strategic property advice regarding the Westlime Drainage Reserve upgrade off Condobolin Road, Parkes.

This report presents the costs that would be incurred by Council to achieve a robust trunk drainage system between the Westlime Detention Basin and the Flinders Street Drainage Reserve.

#### Recommendation

#### 7.6 Mayoral Minute - Parkes Secures Funding for Community and Youth Projects

Eight Parkes Shire projects have been successful in the third round of the NSW Government's Stronger Country Communities Fund (SCCF).

# 7.7 Mayoral Minute - Federal Funding to Fix Black Spots

- Vehicle-activated signs on Adavale Lane east of Braeside Lane (\$95,000).

## **Executive Summary**

The global pandemic of the Coronavirus (CORVID-19) has seen unprecedented actions being taken by Governments around the world. These actions are designed to slow down the spread of the virus so that medical services are not overwhelmed, and lives are saved. The actions are largely based around prevention, through good hygienic practices, or by social distancing to prevent human to human transmission, either directly or indirectly, through close contact with an infected person.

The National Cabinet formed to implement the advice from Australian Health Protection Principal Committee (AHPPC) regarding the pandemic, has introduced a number of recent directives to enforce some social distancing strategies including enforcing all visitors traveling into Australia to self-quarantine for 14 days, barring of cruise ships from docking at Australian ports and limiting any static gatherings of people to less than 500 persons.

Parkes Shire Council has a responsibility to manage the health risks to its employees, contractors, councillors, visitors and customers that attend its workplaces. To that end, a risk based alert strategy has been developed to guide Council's response as the pandemic unfolds over the coming weeks and months.

#### Recommendation

That in relation to the controlling of COVID-19, that Council;

- 1. Proactively support any Government directive and/or guideline.
- 2. Limit organisational travel outside the region to essential purposes only
- 3. review all proposed events/gatherings anticipated to be in the vicinity of 500 and ensure promotors are aware these events must be cancelled.
- 4. review all proposed public events/gatherings less than 500 and work with organisers as to the need for these gatherings, encouraging social-distancing.
- 5. review all its own events and assess the need for these gatherings/meetings encouraging social-distancing where practicable
- 6. review and test our Business Continuity plan, particularly to manage staff absences to ensure services are maintained.
- 7. Endorse the DRAFT WORKPLACE POLICY Infection Control and Infectious Disease Containment Guidelines, knowing it will need to be actively changed.
- 8. Advocate for increased local procurement to help our local Businesses
- 9. That the Mayor and in his absence the Deputy Mayor, be the outwards Council spokesperson on COVID-19.
